What are the tax benefits for donors?

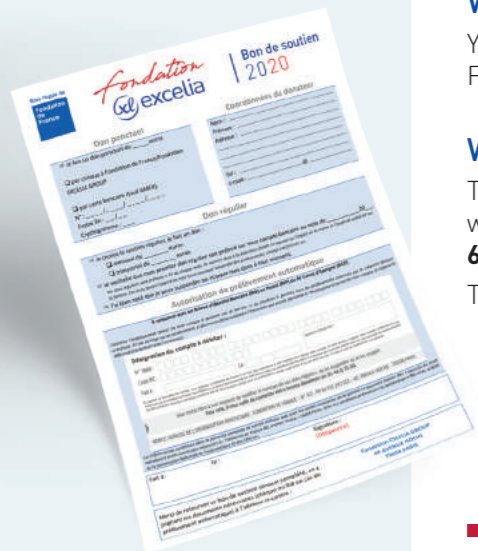
The Excelia Foundation falls under the auspices of the Fondation de France, which means that donors benefit from tax reductions: **60% for corporation tax, 66% for income tax and 75% for wealth tax.** These reductions are capped by current legislation.
