CALL FOR PAPERS

Context:

The rapid evolution of digital technologies and the rise of Artificial Intelligence (AI) are transforming economic, social, and political dynamics on a global scale. These technologies pose critical challenges regarding corporate sovereignty, individual freedoms, and personal data protection. As digital networks become essential infrastructures for social and economic interactions, the issues of control and governance over personal data are increasingly central.

These research days aim to bring together scholars from various disciplines, consultants, businesses, local authorities, and other stakeholders to explore the role of AI and networks in safeguarding digital sovereignty while respecting individual freedoms.

The 5th International Research Days on Artificial Intelligence (JIRIA 5) will be held on November 26 and 27, 2025, at the EXCELIA campus in Paris-Cachan.

This highly anticipated event will bring together professionals, experts, and researchers from various disciplines to explore the challenges of artificial intelligence and digital technologies, examining both their potential and their limitations.

Researchers, consultants, companies, and other interested parties are invited to submit an abstract (max. 500 words), specifying the thematic area addressed. Submissions should be sent to: jiria@excelia-group.com, before May 26 (2025) The authors of the selected contributions will be invited to present their work at the research days. Their papers may be published in partner academic journals.

SUBMISSION AND EVALUATION PROCESS

Authors are invited to submit an intention to present in French or English via email to jiria@excelia-group.com.

Abstract Requirements (max. 2 pages / 6,000 characters):

- Full name, email, and affiliation (university, organization, company, or association)
- Title of the submission
- Thematic area(s) related to the presentation
- 3 to 5 keywords
- Selected bibliography

Types of Submissions:

- Published or in-progress articles that you'd like to update or expand.
- Draft articles for discussion before publication.
- Ongoing doctoral research.

Alternative Formats

- Testimonies, posters, videos, etc., aimed at sharing practical experiences.
- Short text (max. 1,500 words, including bibliography and appendices) explaining the topic and feedback sought.
- Format may include: Introduction/Objectives, Approach/Methodology, Results, Discussion, Implications, and Limitations.
